2026-2027 SCHOOL POLICY

ATTENDANCE

School Hours: Monday to Thursday 8:00am - 3:00pm and Friday 8:00am - 12:00pm

Students may be dropped off as early as 6:50am, breakfast ends at 7:45am, and school begins promptly at 8:00am. Absences and tardies are considered excused only when a doctor's note is provided. Students picked up more than 15 minutes after dismissal will be considered after care with a fee of \$25 per day that will be due before the student returns to school. Parents will receive notifications for excessive tardiness and absences. After six tardies, a student will earn a 1 day in school suspension. Students with five or more absences (excused or unexcused) cannot earn Honor Roll recognition. Tardies and Absences affects enrollment. We encourage all students to attend school daily, as regular attendance is required by Florida law.

UNIFORM

Complete school uniform is required to attend school. Parents will be notified to pick up any student out of uniform. Boys must wear belts daily. Boys cannot wear earrings and girls cannot wear facial earrings. Girl's hair must be neat, and boy's hair must be cut close to the head, braided or pulled back. See the attached Uniform Policy. Each student must practice proper personal hygiene.

ACADEMICS

Each student is required to set and keep their goals daily. Failure to keep up with assignments will result in a student being placed on Academic Probation, leading to out of school suspension, and if continued a dismissal from the school. Homework must be completed each night that it is assigned, and the agenda signed daily.

CHARACTER/BEHAVIOR

Students are expected to respect themselves, their classmates, and all staff. Fighting, bullying, name-calling, foul language, cyberbullying, and disrespectful behavior will not be tolerated. These actions may result in suspension or dismissal from the school. Students are responsible for damage to school property. Parents are also expected to behave respectfully, as their conduct may affect their child's enrollment.

Chapel is held every Wednesday from 12:30pm to 2:30pm. No early pick-ups or appointments should be scheduled during this time. Chapel participation is graded, and chapel grades are required for Honor Roll eligibility.

Males must not have earrings, buns, rattails, or mullets. Natural birth hair color only. All students are required to have neat and presentable hair.

PAYMENTS

All school fees must be kept current and paid by the 5th of each month. Monthly payments are applied toward the student's tuition balance. A \$25 late fee will be added each week a payment is overdue. Students may not return to school until their account is current. All outstanding balances must be paid in full before school records or transcripts are released. Fees from student damage must also be paid before student returns.

LUNCH

Breakfast, lunch, and a snack are provided at no cost. Breakfast is served from 7:30–7:45 a.m., lunch is served from 10:45 a.m.–12:30 p.m., and a snack is served before dismissal. Students may also bring lunch from home. Microwaves and refrigerators are not available for student use. Snacks and drinks are available for purchase from the school snack machine.

ELECTRONICS

School computers are for academic use only. Students who damage a school computer will be charged a \$500 replacement fee. Cell phones and other electronic communication devices are not allowed during school days. Any device that is seen or used will be confiscated, and a parent will be notified. The device will be returned to the parent only. Repeated violations may result in suspension. For communication purposes, the school phone will be available.

PHYSICAL EDUCATION

Students are required to attend P.E. every Tuesday and Thursday. Good behavior is expected and poor sportsmanship may result in a failing grade. The P.E. contract must be signed and returned during the first week of school. Students must wear the proper P.E. uniform. Parents will be notified if a student is not in compliance.

INCOMPLETE YEAR

Students who withdraw before the end of the school year will be charged a **\$300 early withdrawal fee** per student.

CHURCH ATTENDANCE

The Church Referral Form must be completed within a student's first month of school. Weekly church attendance is mandatory for all families attending O.A.C.A.

DRUG/ALCOHOL TESTING CONSENT FORM

(Students in grades 6-12 only)
